DOH-WALTON UPDATES POSITIVE CASES OF COVID-19

DeFuniak Springs, Fla. – DOH Walton/Walton Community Health Center is conducting free COVID 19 testing in DOH-Walton locations in Santa Rosa Beach and DeFuniak Springs by appointment only. Call 850-401-6453 for more information and to schedule a drive-up appointment. Antibody tests are not available.

Demographic information on cases due to ongoing epidemiological investigations, are provisional and subject to change: There are 21 new Walton County cases reported for December 13th. Walton County total cases (4198). Municipalities by zip code can be found on the dashboard (click on the bottom of the page Cases by Zip code). FloridaHealthCOVID19.gov. Community data excludes outbreaks at Correctional Facilities, Long-Term Care Facilities, and out of state residents tested in Walton County. The median age for 12/13 is 61. Community cases (21) age group 0-4 (0), 5-14 (0), 15-24 (2), 25-34 (2), 35-44 (1), 45-54 (3), 55-64 (4), 65-74 (6), 75-84 (2) 85+ (1).

There have been 40 deaths in Walton County. Current COVID19 Hospitalizations in Walton County Hospitals (10) This data may include persons other than Walton County cases.

Included in total cases is 360 Walton County Correctional Institute staff and inmates, (past outbreak numbers included in total positive cases include 96 Walton County jail staff and inmates, 28 Walton Academy for Growth and Change staff and inmates, located in DeFuniak Springs which are listed as DeFuniak Springs cases).

Included in total cases is current and past outbreaks of (170) residents and/or staff that have tested positive for COVID-19 in Long Term Care Facilities in Walton The daily COVID-19 report also includes information from the Agency for Health Care Administration, by county about cases and deaths related to staff or residents in long-term care facilities his report is also available at <u>FloridaHealthCOVID19.gov.</u>

Effective July 2, 2020, COVID-19 confirmed through antigen testing are included in overall case counts. Antigen tests are a new way to check for active COVID-19 infection at the time of your appointment.
